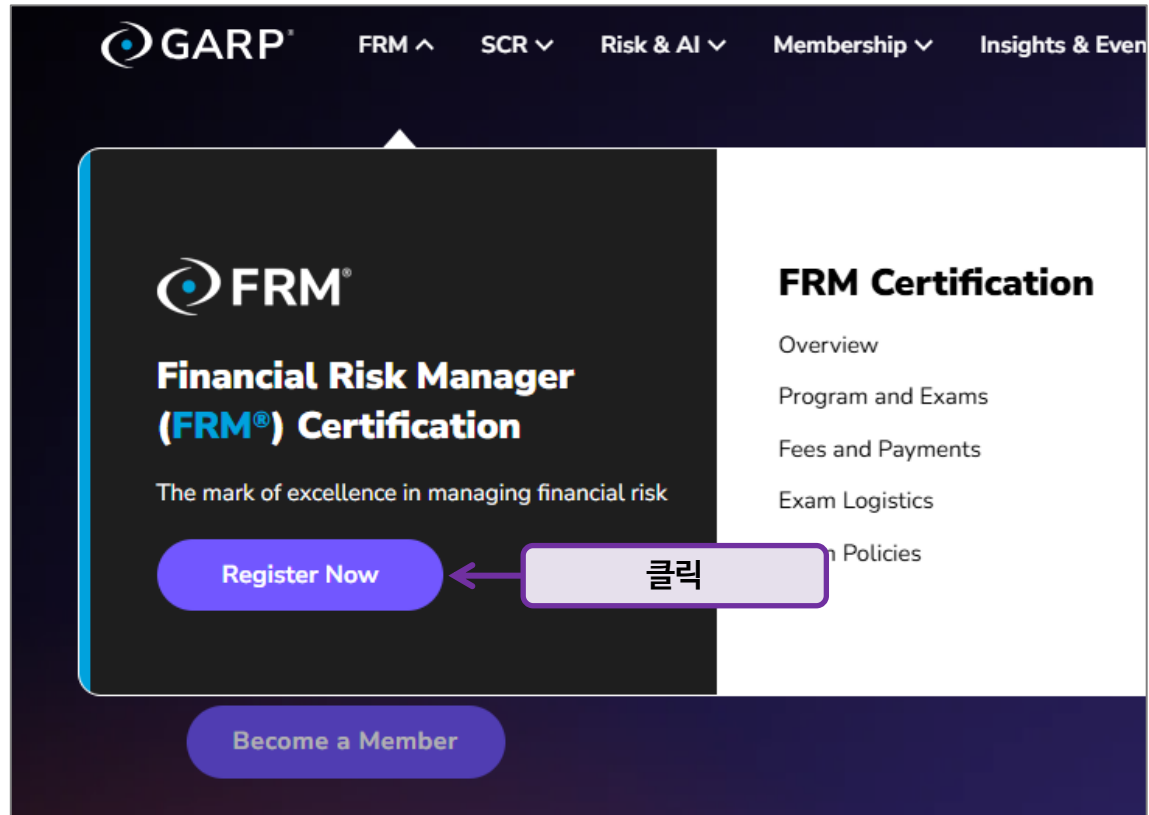

시험 접수 후 절차 - 시험 일정 예약 및 주의 사항

1. 시험 등록 후, 시험 예약/시행 기관 PSI를 통해 실제 시험 일정을 별도로 예약해야 합니다.
2. 시험 기간 별로 게시된 예약 마감일까지 일정을 예약해야 하며, 좌석은 선착순으로 배정됩니다.
3. 예약한 시험 일정은 같은 시험 기간(window) 내 다른 날짜/시간으로 1회에 한해 변경할 수 있습니다.

단, 다음 시험 기간으로 연기(Defer)하는 경우는 별도 절차이며, 1회에 한해 USD 250의 연기 수수료가 부과됩니다.
4. 일정 변경 및 연기는 모두 각 시험 기간에 게시된 마감일까지만 가능합니다.
마감일 이후 예약을 하지 않았거나 시험 당일 응시하지 않은 경우, 시험 비용은 환불·연기·타인 양도가 모두 불가능하며 전액 소멸됩니다.
